Regarding the above matter and the Statement of 27 February 2024, we note that consideration of questions 4 and 5 regarding casual and part-time employment will commence during Monday's consultation session (4 March 2024), after the conclusion of the rest of the parties' submissions relating to questions 6, 7 and 8.

I appreciate that this may be a difficult question to answer however I was wondering if there may be an indication as to when the discussion of the casual and part-time questions may commence during Monday's consultation session?

Due to a number of pre-existing commitments for the morning of Monday 4 March, I am concerned that the earliest availability I have to participate on Monday's session would be 12.45pm AEDT on Monday 4 March. The AHA was not previously intending on participating in consultation for questions 6, 7 and 8 so the prior commitments were made for 4 March and are regrettably unable to be rescheduled.

I do not wish to inconvenience or interrupt proceedings by attending late or part-way through so I thought I would query whether there may be an indication of when the discussion of questions 4 and 5 may commence?
