It is directed that:

#### Groups 3 and 4 (listed at <u>Attachment A</u>) – Substantive claims

- 1. On or before **4.00 pm on Thursday 12 November 2015** each interested party is to file in the Commission:
  - a written outline of submissions in relation to any <u>additional</u> substantive claims or variations being pursued in the Group 3 and 4 awards. The written outline should identify the scope of any evidentiary material that is to be filed and indicate whether the matter should be referred to a separately constituted Full Bench. (Claims submitted in accordance with the Directions issued on 23 January 2015 need not be re-submitted.)
- 2. A further mention will be listed for **10.00 am** on **Monday 14 December 2015** to discuss any additional substantive issues in Group 3 awards and discuss substantive issues and scheduling for Group 4 awards.
- **NOTE:** The Full Benches dealing with these substantive claims will issue separate directions in due course.

#### Group 3

- **3.** On or before **4.00 pm on Thursday 10 March 2016** each interested party is to file in the Commission comprehensive written submissions on the technical and drafting issues related to exposure drafts in Group 3.
- 4. On or before 4.00 pm on Thursday 7 April 2016 each interested party is to file in the Commission comprehensive written submissions in reply to the technical and drafting issues related to exposure drafts in Group 3.
- 5. The Group 3 technical and drafting matters will be listed for hearing before a Full Bench on 2–3 May 2016.

#### Group 4A to 4C – Technical and drafting issues

- 6. On or before 4.00 pm on Thursday 12 May 2016 each interested party is to file in the Commission comprehensive written submissions on the technical and drafting issues related to exposure drafts in Groups 4A, 4B and 4C.
- 7. On or before 4.00 pm on Thursday 23 June 2016 each interested party is to file in the Commission comprehensive written submissions in reply to the technical and drafting issues related to exposure drafts in Groups 4A, 4B and 4C.
- 8. The sub-group 4A, 4B and 4C matters will be listed for hearing before a Full Bench in August 2016.

#### Group 4D to 4F – Technical and drafting issues

- **9.** On or before **4.00 pm on Thursday 7 July 2016** each interested party is to file in the Commission comprehensive written submissions on the technical and drafting issues related to exposure drafts in Groups 4D, 4E and 4F.
- **10.** On or before **4.00 pm on Thursday 18 August 2016** each interested party is to file in the Commission comprehensive written submissions **in reply** to the technical and drafting issues related to exposure drafts in Groups 4D, 4E and 4F.
- **11.** The sub-group 4D, 4E and 4F matters will be listed for hearing before a Full Bench in **September 2016**.
- **12.** Leave is granted to apply generally.
