Thank you for confirming and granting this extension.

I can now advise that MIAL will not be responding to the MUA submissions made on 6 December 2016 as we have not identified any members with part-time employees under the Ports, Harbours and Enclosed Water Vessels Award.

Whilst I personally have some concerns about whether parties that may be impacted by the proposals made by the MUA are represented in this process (likely to be small regional businesses and owner/operators), MIAL will not be making submissions.
