The Association represents plumbing contractors working in all the different scopes of work within the plumbing industry i.e. major construction, industrial, commercial and maintenance. The Association under its rules has coverage in New South Wales and also in the Australian Capital Territory.
2. MPMCA filed a submission in relation to the clause 18 of the Plumbing and Fire Sprinklers Award 2010 - Industry Specific Redundancy Scheme (ISRS) - on 30 June 2016. This submission still represents MPMCA's substantive view on the matter however MPMCA does not intend to run this claim at present time.
3. MPMCA reviewed and considered submissions by the Master Builders Australia (MBA) to substantiate their application to vary clause 17 of the Building and Construction General On-site Award 2010 which is identical to clause 18 Plumbing and Fire Sprinkler Award 2010.
4. MPMCA supports the MBA submission in regard to the variation of the ISRS as it appeared in both the Plumbing and Fire Sprinklers Award 2010 and the Building and Construction General On-site Award 2010.
5. MPMCA seeks to reserve our right to appear at the relevant hearings and be provided with the opportunity to respond to the submissions of other parties as relevant.
