The Australian Industry Group (Ai Group) does not oppose the request made, however we note that this matter is listed for mention before Deputy President Gooley at 10am on 28 November 2017. The notice of listing issued indicates that parties "must be in a position to inform the Commission of the witnesses required for cross-examination, and an estimate of the length of time required for cross-examination" during those proceedings.
