 Lloyd Helicopters Pty Ltd T/A CHC Helicopters ("CHC") writes to put forward submissions in relation to the draft proposed *Helicopter Aircrew Award 2018* ("Proposed Award") in Attachment A to the submissions of the Australian Manufacturing Workers' Union ("AMWU") dated 13 April 2018 ("AMWU April Submissions").

About CHC

- 2. CHC is the Australian operation of CHC Helicopters, a global helicopter services company. CHC Helicopters is headquartered in British Columbia, Canada and operates more than 129 aircraft in 30 countries around the world.
- 3. CHC Helicopters is a global leader in Helicopter Services, Helicopter Emergency Medical Services, Search and Rescue ("SAR") and Helicopter Maintenance, Repair and Overhaul. It is a world leader in the provision of transportation to offshore oil and gas platforms and vessels, operating in almost every major oil-producing region in the world. CHC also operates one of the world's largest networks of SAR services. Heli-One (a subsidiary of CHC Helicopters) is the world's largest helicopter support company. It delivers comprehensive and innovative solutions that maximise safety, optimise mission readiness and reduce total cost of ownership.
- 4. CHC Helicopters currently employs approximately 2790 people worldwide. CHC employs approximately 410 as part of its Australian operations.
- 5. As one of the largest helicopter services companies operating within Australia, CHC has a vested interest in the Proposed Award.

Overview of Objections

- 6. CHC has reviewed the AMWU submissions, the supplementary submissions provided by Babcock Mission Critical Services Australasia Pty Ltd ("Babcock") dated 20 April 2018 ("Babcock April Submissions") and the submissions in reply provided by the AMWU on 27 April 2018 ("AMWU April Reply Submissions"). The submissions set out below have been drafted on the basis of the status of the relevant issues as contained in those documents.
- 7. CHC objects to a number of the terms in the Proposed Award as currently drafted. These include:
 - (a) Clause 19.6 Other Required Additional Skill Certification Allowance
 - (b) Clause 19.7 Fitness Allowance
 - (c) Clause 19.9 Overseas Allowance
 - (d) Clause 19.26 Income Protection Insurance
 - (e) Clause 27 Overtime Days Worked
 - (f) Clause 28 Overtime Hours Worked
 - (g) Clause 32 Jury Service Leave

Terms in the Proposed Award

Clause 19.6 - Other Required Additional Skill Certification Allowance

- 8. CHC is concerned that by removing the monetary amount for the allowance that was included in earlier drafts, it creates the potential for uncertainty and disagreement amongst the workforce.
- 9. CHC also supports the Babcock April Submissions in relation to this clause.

Clause 19.7 - Fitness Allowance

10. CHC supports Babcock's submission that this allowance would be more appropriately dealt with through enterprise bargaining. The CHC Helicopters (Australia) Crewperson Enterprise Agreement 2017 – 2019 ("CHC Agreement") includes a fitness allowance and CHC agrees that the amount of such an allowance (if required) will vary depending on the size and operations of the particular employer.

Clause 19.9 - Overseas Allowance

- 11. The CHC Agreement includes an 'appropriate allowance' for operations that are considered remote or overseas. The amount of this allowance varies depending on the location of the employee.
- 12. CHC supports Babcock's proposal of utilising the Australian Taxation Office's *Taxation Determination TD 2017/19 Reasonable travel and overtime meal allowance expense amounts* for overseas travel based on which country the employee is visiting.

Clause 19.26 - Income Protection Insurance

- 13. Although the CHC Agreement provides for income protection insurance on very similar terms to what is proposed by the AMWU, CHC is of the view that this is a benefit that would be more appropriately dealt with through enterprise bargaining.
- 14. CHC supports the Babcock submissions dated 6 December 2017 ("Babcock December Submissions") in relation to this issue.

Clause 27 - Overtime Days Worked

- 15. The overtime provisions included in the CHC Agreement are based on fixed overtime rates, not on the employee's ordinary daily rate.
- CHC supports the Babcock April Submissions and the Babcock December Submissions in relation to this clause.

Clause 28 - Overtime Hours Worked

17. CHC supports the Babcock April Submissions in relation to this clause.

Clause 32 – Jury Service Leave

- 18. CHC is of the view that the number of paid jury service leave days should be capped at ten days in line with the National Employment Standards.
- 19. CHC supports the Babcock April Submissions in relation to this clause.
