*Fair Work Act 2009*

s.156 - 4 yearly review of modern awards

## **Alpine Resorts Award 2010** (AM2016/30)

The Fair Work Commission makes the following determination:

A. It is ordered that the *Alpine Resorts Award 2010* be varied as follows:

1. The words ‘**alpine resort** means an establishment whose business, among other things, includes alpine lifting’ to be deleted from Clause 3.1;
2. The following words to be added to Clause 3.1;

*alpine resort means:*

- (a) *any establishment whose business, among other things, includes alpine lifting;  
and/or*
- (b) *any establishment which has statutory responsibility for management and  
operation of an alpine resort, whether or not that establishment operates an  
alpine lift.*

3. Clause 4.1 to be amended to read:

*This industry award covers employers throughout Australia who operate or have  
statutory responsibility for management and operation of an alpine resort and their  
employees in the classifications within Schedule A – Classification Definitions to the  
exclusion of any other modern award.*
