Re: AM2017/56 – *Sugar Industry Award 2010*

I refer to the [correspondence](#) received from the NFF and the AWU in relation to proposed clause 20.2(f) of the draft determination published on 4 October 2019, and the inclusion of a 'formula' illustrating the operation of that clause.

Having regard to the proposal of the NFF and the views of the AWU in relation to the inclusion of a formula, it is the provisional view of the Full Bench that there is utility in including a clause containing a formula to clarify the operation of clause 20.2(f). Please see the attached amended version of the draft determination, with an amendment made at item 11 in response to the issue.

Minor amendments have also been made at item 1 to correct a minor typographical error, and at item 10 to include specific clause references.

If there are no objections received from the parties, the Full Bench will proceed to finalise the determination.
