Re. AM2018/26 Social, Community, Home Care and Disability Services Industry Award 2010 – Request for extension of time

We refer to the above matter.

On 3 September 2021, the Fair Work Commission (**Commission**) issued directions requiring the filing of submissions and any evidence in response to the questions set out in the Commission's statement¹ of the same date at paragraph [21], by 4.00pm on 15 September 2021. In its statement, the Commission went on to observe that *'[i]f possible, the various interests should seek to collaborate and file joint submissions (i.e., Joint Employer and Joint Union submissions)'*.

The Australian Industry Group, the Australian Federation of Employers and Industries, Australian Business Industrial, Business NSW, Aged and Community Services Australia, Leading Age Services Australia and National Disability Services (collectively, **Employer Parties**) have been collaborating for the purposes of endeavouring to file a joint submission.
