# INDEPENDENT EDUCATION UNION OF AUSTRALIA APPLICANT

## **IEU CALCULATIONS RE TRANSITION**

- The annexed table contains four tables modelling the impact of the AFEI's proposed translation and progression regime. The calculations are based on AFEI's proposed commencement date, and are intended to demonstrate the issue which arises from relying on years of service 'at level 2' rather than counting years of previous satisfactory service.
- 2. Tables 1 and 3 assume a 4-year qualified teacher with a commencement date of 1 July 2018. This teacher would, as at 1 July 2022, have achieved four completed years of teaching experience and two years (assuming normal progression) of experience post-proficient accreditation, and be classified as:
  - a. a level 7 under the current scale,
  - b. a level 2 under the IEU/ACA and AFEI scales.
- 3. Each of the Tables demonstrate that there will be years where the teacher will in that year be being paid less than they would have been paid if the classification and pay rates remained the same.
- 4. The Tables further quantify and compare the total sums paid over time, as summarised in the following paragraphs. It should be noted that the comparison is made against the current rates (that is, with no work value adjustment) and the adjusted rates. No future wage increase has been factored in.

- 5. Table 1 shows that the teacher would be, by 1 July 2025, \$537 worse off under the AFEI proposal than the *current* system, and \$12,028 worse off than under the IEU/ACA proposal. Table 3 shows that over 7 years, the teacher under the AFEI proposal will end up only \$531 (in total) better off than they would have been under the current system, as opposed to \$23,856 under the IEU/ACA proposal.
- 6. Tables 2 and 4 assume the same work experience but with a commencement date of 1 January 2018 (i.e. aligned with the normal school year). This teacher is, under the AFEI system:
  - a. by 1 January 2025, \$1285 worse off than the current system and
     \$8,870 worse off than under the IEU/ACA proposal; and
  - b. by 1 January 2029, only \$1483 (in total) better off than the current system, and \$11,567 worse off than the IEU/ACA proposal.
