BACKGROUND

- On 16 July 2021, a 5 member Full Bench issued a decision [2021] FWCFB 4144 in relation to Stage 1 of the Casual Terms Award Review 2021 ("the Stage 1 Decision"). The Stage 1 Decision, amongst other things, outlined the statutory framework for the review (nature and scope) and reviewed relevant terms in a first group of 6 modern awards.
- 2. On 3 August 2021, a Statement [2021] FWCFB 4714 ("the August 2021 Statement") was issued by a newly constituted 3 member full bench setting out the process of review of the balance of modern awards.² Attachment A to the August 2021 Statement categorised the remaining modern awards into 4 groupings Group 1, Group 2, Group 3 and Group 4.
- 3. The August 2021 Statement outlined the Full Bench's *provisional views* in relation to the 34 awards in Group 1.³ Interested parties were directed to provide any responses in relation to the Full Bench's provisional views concerning the Group 1 awards (with the exception of the *Meat Industry Award 2020*) by 4:00pm, Tuesday 10 August 2021.
- 4. The Construction, Forestry, Maritime, Mining and Energy Union Manufacturing Division ("CFMMEU MD") has a direct interest in the following modern awards listed in Group 1 of Stage 2:
 - Dry Cleaning and Laundry Industry Award 2020 ⁴ ('DC&LI Award')
 - Joinery and Building Trades Award 2020⁵ ('Joinery Award')

DC&LI Award

- 5. The *provisional* views of the Full Bench in relation to the DC&LI Award are contained in Attachment B (page 60) and relate to 4 separate clauses as follows:

 - clause 11.8 casual conversion
 - clause 18.4(f) regular and systematic employee
 - clause 21.8 calculation of accident pay for casuals
- 6. Given the findings (as relevant) made by the Full Bench in the Stage 1 Decision, the CFMMEU-MD does not oppose the provisional views expressed by the current full bench with respect to the DC&LI Award.

7. With respect to the Joinery Award, the CFMMEU-MD supports and adopts the submissions (with relevant attachments) of the CFMMEU – Construction and General Division in relation to Stage 2 (Group 1 Awards), filed on 10 August 2021.⁶
