

#### BACKGROUND

- On 24 May 2021, the Construction, Forestry, Maritime, Mining and Energy Union Manufacturing Division ("CFMMEU – MD") filed a submission in these proceedings pursuant to the Statement and Directions issued by the Casual terms award review 2021 Full Bench.<sup>1</sup>
- 2. As outlined in its submissions of 24 May 2021, with respect to the 6 modern awards in Stage 1, the CFMMEU – MD has a direct interest in the *Manufacturing and Associated Industries and Occupations Award 2020*<sup>2</sup>("Manufacturing Award"). With respect to Stage 2, the CFMMEU-MD has an interest in the following modern awards:
  - Dry Cleaning and Laundry Industry Award 2020<sup>3</sup> ('DC&LI Award')
  - Joinery and Building Trades Award 2020<sup>4</sup> ('Joinery Award')
  - Storage Services and Wholesale Award 2020<sup>5</sup> ('Storage Award')
  - Textile, Clothing, Footwear and Associated Industries Award 2020<sup>6</sup> ('TCF Award')
  - *Timber Industry Award 2020<sup>7</sup>* ('Timber Award')
- A Statement was issued by the Full Bench on 9 June 2021 ("the June 2021 Statement"),<sup>8</sup> together with a Submission Summary Document.<sup>9</sup> At paragraph [8] of the June 2021 Statement, the Full Bench stated:

[8] As flagged in the 23 April 2021 Statement and Directions, with this Statement we publish the Submission Summary Document and make some observations about the positions put by interested parties in response to the questions posed in the Discussion Paper. <u>We have decided to defer expressing any provisional</u> <u>views about the issues raised until after parties have filed any reply submissions</u> (due by 16 June 2021).<sup>10</sup>
