We refer to the "Expert Panel Member Advisory Role Opportunity" for Professor Marian Baird communicated to the parties and representatives by the Chambers of President Hatcher on Monday, 15 January 2024 (the disclosure).

The nature of the disclosure was set out within that communication, together with the following direction:

"Any party which considers that acceptance of this advisory role would disqualify Professor Baird from further participation in the Expert Panel constituted in these matters is directed to advise the chambers of Justice Hatcher of its position in this respect by 5:00 pm (AEDT) on Friday, 19 January 2024".

The position of the Joint Employers is set out below.

## Joint Employers' Response

In the context of the current proceedings, the Joint Employers do not consider the acceptance of the advisory role would disqualify Professor Baird from further participation in the Expert Panel as constituted for this matter.

In forming that view, we note the following:

- Some initial reservations may arise due to the possible appearance or apprehension
  of bias arising from a current member of the Expert Panel in the Work Value Case
  giving advice ostensibly to an Applicant in the proceedings, namely, the HSU.
  However, having regard to the projected timing of the appointment and noting that
  judgment is reserved in the Work Value Case, materialisation of any reservations likely
  fall away as a consequence of timing.
- 2. Looking forward, acceptance of the appointment may increase the appearance or apprehension of bias in future matters before Professor Baird that relate to the care and community sector (e.g. an application in relation to the disability sector) but that is

a matter to be considered at that time and does not alter the position of the Joint Employers stated above in this matter.

On Friday, 12 January 2024, Professor Marian Baird, a member of the Expert Panel constituted to determine the above matters, informed Justice Hatcher of an invitation she has received to work on a project to be conducted by the Health and Community Services Union (HACSU) Victoria, a branch of the HSU.

The HACSU represents workers in mental health, disability, and drug and alcohol services across Victoria and has won a grant from WorkSafe's WorkWell Respect Fund to develop and evaluate policies and practices for the prevention and early intervention of gendered and sexual harassment for frontline healthcare workers.
