- A. Further to the decision issued by the Expert Panel in the Annual Wage Review 2018–19 on 30 May 2019 [[2019] FWCFB 3500], the above award is varied as follows:
- 1. By deleting the amount "\$793.50" appearing in clause 13.1 and inserting "\$817.30".
- 2. By deleting the table appearing in clause 13.2(a) and inserting the following:
