Annual Wage Review 2018–19 — Junior rates of pay in modern awards C2019/1

SUBMISSIONS OF THE AUSTRALIAN RAIL, TRAM AND BUS INDUSTRY UNION

The Australian Rail, Tram and Bus Industry Union (“**RTBU**”) acknowledges that the junior rates under the Rail Industry Award 2010 do not fall below those provided for in the National Minimum Wages Order 2018.

However, the Rail Industry Award 2010 has apprentice rates which fall below the apprentice rates in the National Minimum Wage 4 (“**NMW4**”).

NMW4 Apprentice Rates

NMW4 provides for apprentice rates for award/agreement free employees as follows:

Apprentices

To be paid in accordance with 14.2 of the Miscellaneous Award 2010 which provides:

Apprentice	Standard rate	Percentage	Hourly rate
1st year	22.04	55%	12.12
2nd Year	22.04	65%	14.33
3rd Year	22.04	80%	17.63
4th Year	22.04	95%	20.94

Adult Apprentices - commencing on or after 1 Jan 2014

To be paid in accordance with 14.2 of the Miscellaneous Award 2010 which provides:

Adult Apprentice	Standard rate	Whichever greater	Hourly rate
1st year	22.04	80% of standard	17.63
2nd Year	22.04	Lowest rate in 14.1	18.93
3rd Year	22.04	Lowest rate in 14.1	18.93
4th Year	22.04	apprentice rate higher	20.94

Adult Apprentices - commencing before 1 Jan 2014

Paid in accordance with the non-adult apprentice rates however, in accordance with NMW4 if the adult apprentice was engaged before 1 July 2014 and is in their first year of apprenticeship must be paid \$16.37p/h.

Rail Industry Award Apprentice Rates

Apprentice rates in the Rail Industry Award 2010 are paid as a percentage of two classifications:

Level	Classification	Weekly Wage
4	Rail Worker (T.C.I)	837.4
3	Rail Worker (Operations)	846.7

The following apprentice rates in **RED** from the Rail Industry Award 2010 fall below those in NMW4.
