Expense-related allowances.

- A. Pursuant to s.157 of the *Fair Work Act 2009*, the above award is varied as follows:
1. By deleting the amount “\$20.02” appearing in clause 18.3(g) and inserting “\$20.89”.
 2. By deleting the amount “\$16.41” appearing in clause 18.5(a)(i) and inserting “\$16.79”.
 3. By deleting the amount “\$0.80” appearing in clause 18.6(b) and inserting “\$0.91”.
 4. By deleting the amount “\$6.47” appearing in clause 18.6(c) and inserting “\$6.77”.
 5. By deleting the amount “\$21.06” appearing in clause 18.6(d)(i) and inserting “\$22.02”.
 6. By deleting the amount “\$3.78” appearing in clause 18.6(d)(iii) and inserting “\$3.95”.
 7. By deleting the amount “\$0.80” appearing in clause 18.6(f) and inserting “\$0.91”.
 8. By deleting the amount “\$536.49” appearing in clause 18.7(a)(i) and inserting “\$561.05”.
 9. By deleting the amount “\$16.41” appearing in clause 18.7(a)(iii) and inserting “\$16.79”.

10. By deleting the table appearing in clause C.2.1 and inserting the following:
