 3. By deleting the amount “\$14.87” appearing in clause 19.5(b)(i) and inserting “\$15.21”.
 4. By deleting the amount “\$12.44” appearing in clause 19.6(a) and inserting “\$12.98”.
 5. By deleting the table appearing in 19.6(b) and inserting the following:

6. By deleting the amount “\$17.63” appearing in clause 28.7(c)(i) and inserting “\$18.04”.

7. By deleting the amounts “\$178.02”, “\$0.21”, “\$197.83” and “\$0.24” appearing in clause 28.7(d)(ii) and inserting “\$203.26”, “\$0.24”, “\$225.88” and “\$0.27” respectively.

8. By deleting the amount “\$0.80” appearing in clause 28.7(d)(vi) and inserting “\$0.91”.

9. By deleting the table appearing in clause C.1.2 and inserting the following:
