5. By deleting the amounts “\$176.91” and “\$470.84” appearing in clause 17.3(d)(iii) and inserting “\$185.01” and “\$492.39” respectively.
6. By deleting the amount “\$470.84” appearing in clause 17.3(e)(i) and inserting “\$492.39”.
7. By deleting the table appearing in clause 17.3(e)(ii) and inserting the following:
